### **Welcome**

Chair Aguirre began the meeting by welcoming the officers and directors.

### **Meeting Agenda**

Chair Aguirre presented the slides for the local section meeting on 25-Apr-2023. The EC made minor changes to the slides as needed. Treasurer Dickey will incorporate the current financial report into the slides.

Chair Aguirre informed the EC that Texas Instruments had declined our request for a plant tour of the Richardson site as they only provide plant tours to customers with business needs. Therefore, a speaker will need to be found for the May 2023 local section meeting.

The upcoming local section meeting (25-Apr-2023) will be a hybrid meeting with the speaker being remote. To date, 6 members have signed up to attend the meeting remotely. This hybrid meeting will be a good test to see if future hybrid meetings are viable with the current equipment. Treasurer Dickey indicated that he tested the inputs/outputs for the laptop and speaker system and confirmed they are compatible.

Past Chair Tossetti indicated that she had approached Paul Cannizzo (HSB Solomon Associates) to determine his interest in presenting a sustainability presentation to the local chapter she will report back her findings at a future EC meeting.

Treasurer Dickey indicated he is working on the financial reports for National AICHe. Treasurer Dickey also indicated that the Federal tax returns need to be filed by May 15, 2023.

The EC discussed the proposal from Director Droge for a Young Professional Event. The event will be scheduled in the May/June 2023 timeframe and will have a budget of \$1,000 total (\$50 per person up to 20 people total). Chair Aguirre made a motion to approve the Young Professional event as described and Director Riddle seconded. The EC voted unanimously to approve the Young Professional event.

The Regeneron International Science and Engineering Fair (held in Dallas, May 14-19, 2023) is still looking for volunteers. To date, Past Chair Tossetti has been accepted as a judge at the fair.
